 Please DO NOT GO into the Main Indoor Arena with your horse unless invited in.

### Where: Ford Idaho Horse Park, Park on the Northside by other horse trailers.

Participants need to enter off Idaho Center Blvd, and follow the Participants signage.  
 Participants will receive entry ticket(s) the day(s) of your clinic. Anyone accompanying you will need to purchase Expo tickets.  
 No horses will be allowed in the Expo Building or any other arena other than directed to by the Committee.  
 Youth under the age of 18 must have a parent sign the liability release form to participate.  
 Un-sportsman like conduct will be grounds for disqualification and forfeiture of all entries fees paid.  
 NO DOGS allowed anywhere on the grounds.
