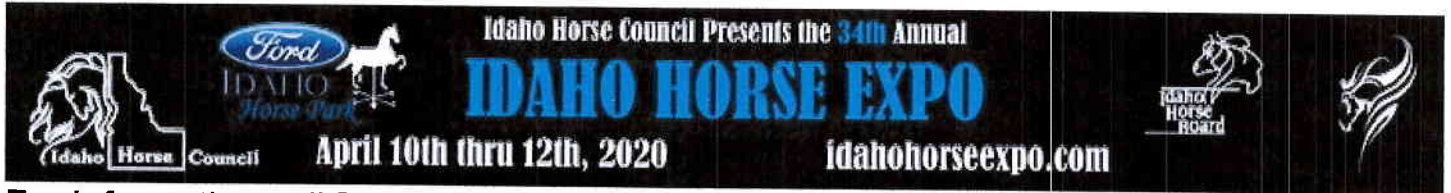

## Division and Entry Fees (You may enter up to 2 classes if you qualify):

Youth Division (ages 12-17) - \$30

- Youth contestants are required to provide and wear a helmet, unless a helmet release form is signed by a parent at registration.
- If the youth is/has worked as a Trainer, or given lessons in the last 7 years, they must enter the Open class only.

Amateur Division - \$50

- If a horse/rider combination has won the Amateur Division in prior years – they must move up to the Open Division, or if the rider is/has worked as a trainer or given lessons in the last 7 years, they must enter the Open class only.
- Amateur Division contestants must be the horse owner, or the horse must belong to a family member (leased horses are not eligible).

Open Division - \$50

Passes to the Expo: (Rider will receive a One-Day Pass with pre-registration)

2nd Chance Jackpot class (limited to 10 riders): Only Division Class Entries are eligible.

2nd Chance class - \$25

Entry directions: Please remit payment, entry form and signed release form. Entries are limited to 40 total entries in division classes and will be processed on a first come first served basis. **Pre-entry deadline is postmarked by April 1st.** If the race is not full, entries will be accepted until 9:15 am the day of the race. Pre-entry riders will receive a 1 day pass to the expo free of charge. Additional helper passes must be purchased.

Long sleeves and a western hat/helmet are required.

Riders not at the gate when their name is called will be disqualified and not allowed to compete. No refunds will be given. Riders that are committed to a performance at the Expo will be given consideration. Each horse may only be ridden by one person. Any horse deemed unsafe will be disqualified. No mares with colts on course.

This course is timed; there will be no scores. All obstacles to be completed as described by course map. If an obstacle is not completed as described there will be a time penalty. If an obstacle is not attempted or skipped a double time penalty will be given. 3 attempts at the obstacle and rider will be asked to move on; a time penalty will be incurred. Maximum time allowed on course is 10 minutes.

This race is a jackpot. All entry fees will be paid out plus an added amount by IHC. Amateur & Open class will pay out to top 3 riders. Youth payout is to top 2 riders.

**NO DOGS!** Unsportsmanlike conduct will be grounds for disqualification and forfeiture of all entry fees paid.

- 9:00 AM Order of go draw, Open class 1st, Am 2nd, Youth 3rd
- 9:15 AM Registration closes (if registered after the draw - you go first in your class) (limit 40 total)
- 9:30 AM 1st Rider on course
- 3:30 PM 2nd Chance Jackpot class begins (limit 10 riders)
- 4:30 PM Results for main classes with be announced inside the main arena

Preregister by April 1st and receive a One-Day Pass for the Expo.

If you do not preregister you will have to buy your own entry to the Expo.

Each additional person you wish to bring in the back gate must purchase a pass.

Passes will be sold at the back gate.
